ACKNOWLEDGEMENT OF INTERIM CRITERIA AND APPLICATION OF FUTURE ASSESSMENT

By executing and submitting this application, the applicant acknowledges that the Tahltan Central Government is currently developing a policy for determining which businesses qualify as Tahltan businesses and for tracking such businesses on a “Tahltan Business Registry” and that, while such a policy is being developed, the TCG has approved the following interim definition of “Tahltan Business”:

“Tahltan Business” means a business:

- that is majority owned and controlled by one or more Tahltans; or*
- in which the Tahltan Nation Development Corporation has a material interest.*

For the purposes of this definition, “majority owned” will be assessed with reference to the following:

- with respect to a corporation, a corporation that (a) has at least 51% of each class of shares owned by one or more Tahltans, (b) has at least 51% of its capital or stated capital contributed by one or more Tahltans, and (c) if the corporation owes amounts to any of its shareholders, at least 51% of such amounts are owed to one or more Tahltans;*
- with respect to a partnership or joint venture, a partnership or joint venture that (a) has at least 51% of the ownership rights (including voting rights) directly held by one or more Tahltans, (b) has at least 51% of its capital contributed by one or more Tahltans, and (c) if the partnership or joint venture owes amounts to any of its partners or joint venturers, at least 51% of such amounts are owed to one or more Tahltans; and*
- the amount of fees that are paid or payable by the business, directly or indirectly, to a person or persons that are not Tahltan for management and similar services must be less than 50% of the business’ gross income and all agreements with third parties for equipment or services must be on arm’s length terms. For clarity, the foregoing definition is intended to explicitly exclude “brokerage” businesses or marketing arrangements (aka. shell companies).*

This definition will evolve over time and may be revised, replaced, or re-interpreted by resolution of the TCG Board of Directors.

By executing and submitting this application, the applicant also acknowledges that the Tahltan Central Government may establish a third-party confidential assessment process for confirming that the applicant’s businesses meets the applicable criteria to be considered a “Tahltan Business” and that the applicant may be subject to the assessment process in order continue to be recognized as a “Tahltan Business”, which may require providing additional information and documentation. Until such time as a third-party confidential assessment process is established, the Tahltan Central Government will rely on each applicant self-declaring that their business meets the applicable criteria to be considered a “Tahltan Business”.
